

A 200 ha Mega area developed for industrial investments. Located next to the S3 junction and the Katowice - Legnica railway line no. 137. Access directly from municipal roads.




A series of smaller plots starting from 1 ha, intended for international corporation contractors in Jawor. Developed areas, with access to a public road and technical utilities.

Investment opportunities:





CIT/PIT exemption for entrepreneurs

Invest and develop your business without tax burdens




The Wałbrzych Special Economic Zone offers CIT/PIT exemption for entrepreneurs operating in the region.

The amount of an income tax exemption for a new investment is granted on the basis of the decision on support. It depends on the size of the enterprise and investment location.

The maximum amount of public aid is calculated as the percentage of the investment costs eligible for aid. Intensity of public aid is from 15% up to 60%. The infographic below shows the mechanism for calculating an income tax exemption in accordance with the regional aid map for 2022–2027.
