

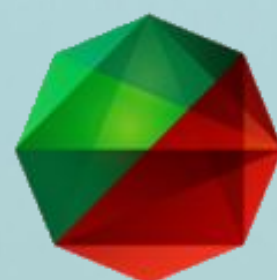

We also provide necessary information about the market (tax system and procedures), key players, competition and consumers' profiles.



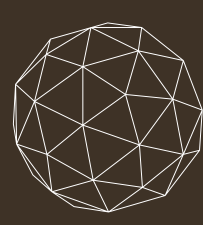
We believe that in-depth and direct knowledge of the market reality of the country is of the utmost importance for sustainable success.

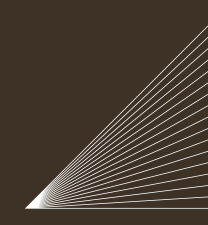
Geostrategic location between Europe, Africa and America. The Most Western point of Europe is Cabo da Roca, located in the municipality of Sintra

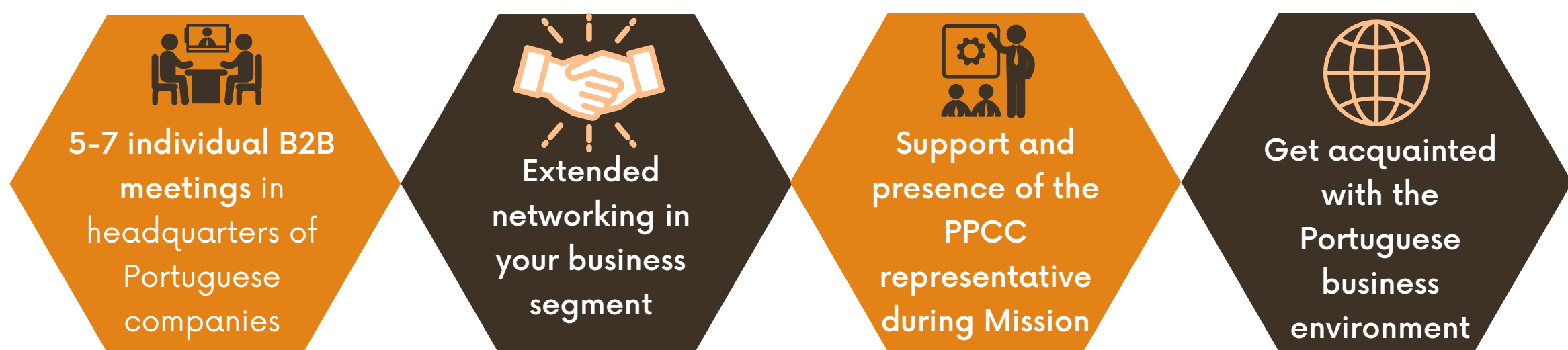

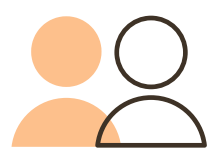
